- Cancel monthly contract with janitorial service for indoor cleaning will contact them on an as-needed basis instead.
- Superior Fence will provide estimate to install gate at west entry.
- West side railing behind building is loose. Request Oscar Rincon (from Perfect House) to complete repair.
